Default has occurred in the payment of the Note and in the performance of the obligations of the Deed of Trust. Because of that default, La Mancha, LTD., the owner and holder of the Note, has requested Substitute Trustee to sell the Property.

The Deed of Trust may encumber both real and personal property. Formal notice is hereby given of La Mancha, LTD.'s election to proceed against and sell both the real property and any personal property described in the Deed of Trust in accordance with La Mancha, LTD.'s rights and remedies under the Deed of Trust and section 9.604(a) of the Texas Business and Commerce Code.



Prospective bidders are strongly urged to examine the applicable property records to determine the nature and extent of such matters, if any.

Pursuant to section 51.009 of the Texas Property Code, the Property will be sold "AS IS," without any expressed or implied warranties, except as to the warranties (if any) provided for under the Deed of Trust. Prospective bidders are advised to conduct an independent investigation of the nature and physical condition of the Property.


