Therefore, the provisions of Texas Water Code Section 54.5161 are applicable to this application and notification is hereby given that the referenced bond issue application has been filed with the Texas Commission on Environmental Quality (TCEQ). Further, the County has an opportunity, within 30 days after the above dated notification, to examine all information on file and submit a written opinion from the commissioners' court stating any findings, conclusions, or other information that the commissioners' court considers important to the TCEQ's final determination.

The TCEQ will not render a final decision on the above referenced application until after the receipt of commissioners' court comments or upon the expiration of the 30-day submission period, whichever is earlier.


