

## **Waller County Courthouse Survey Responses**





## Comments from those agreeable to the County using COs:

## Comments from those not agreeable to the County using COs:

- 1. I'd like to see this be added to ballot for residents of the county to vote on it. There are other projects within the county that have gone neglected far too long.
- 2. First, I'd like to thank the court for it's transparency and for providing an avenue for the public to view the town hall, as well as the exhibits online. I have viewed the town hall and looked over the schematics of the proposed new courthouse.

Here are my comments with regards to the proposal:

- 1) I agree a new courthouse is warranted considering the condition of the current one.
- 2) I think that the courthouse should be one the community can be proud of. However, in my opinion, each department included EVERYTHING on their Christmas list in the design and for 30 current employees and a projected 60 in 2050, the whole thing can be scaled down to cut costs to taxpayers.
- 3) Additionally, I count 16 staff and private bathrooms in addition to the public ones. There are also, in my opinion, an over abundance of breakrooms & conference rooms.

I have worked in posh offices and have never seen this many bathrooms, conference rooms or break rooms/kitchens. I realize as a public building there exists a need for staff bathrooms where a private company would not. However, one set of staff bathrooms per floor should be ample. The additional plumbing running throughout the building is not only an unnecessary building cost, but will also add to the maintenance cost over the years.

That the court thought this would be acceptable to the public is astonishing, especially in the current economic climate. Now, because of the insensitivity of the board, additional funds will need to be expended to draw up new plans. Unless these excesses are removed, I will not vote for the bond and campaign that no one else do either.

- 3. This building needs to be scaled back. One set of restrooms and one conference room and one break room per floor!
- 4. I believe that would rush any decisions and that's not ok.
- 5. Agreeable to a new courthouse, but it should be up to the taxpayers to decide. Put it to a bond referendum.
- 6. You are paid officials by the tax payers! Please start acting like ones that respect tax payer dollars. Individual bathrooms is a luxury, not a necessity. You know this should be going to bond for the people
- 7. Voters need to decided wharfs going on in our county.

- 10. I understand a new courthouse is needed. Howerever, I am on Social Security. I cannot handle any more taxes! I believe the CO'S would raise property taxes. I do not want to lose my home. I would appreciate serious consideration of people in my position. Thank you.
- 11. I understand the dilemma here. If the bond fails, the CO cannot be issued for 3 years. But the citizens are under too much stress with property taxes and inflation right now and this will only add to it and will infuriate the public when they come to realize it was done. Right now only a small percent of the public is even aware of the consideration of a new courthouse. No one has a crystal ball, but right now is not the time to force this issue. I suggest to wait until after the midterms and put it on the ballot in May. I know the court contends this will cost us in interest, but it may save us interest as well. These are very unstable and uncertain times.

- 12. I understand the logic of locking in a lower interest with a CO for a needed new courthouse. As our elected county government you can do that. I am in RISD and the last 2 bond elections for needed school buildings have failed. Waller county property owners are in STICKER SHOCK from recent appraisal district evaluations. State Republican platform even has the elimination of appraisal districts and property taxes. I would like to see a well presented bond election. Fix the bathroom objection. I appreciate your service and support the construction of a new courthouse.
- 13. This should be passed to Referendum and voting The plans should be voted on as well as total targeted budget allocation
- 14. It seems to me that you only have a possible preliminary building design, and thus a preliminary estimate of \$32 MM which at this point would be a "best guess" situation. Until there is a finalized design and a more accurate cost, my opinion is it's too early for Commissioners Court to decide on using certificates of obligation instead of putting the issue before the voters.
