Summary:

The Engineer is responsible for assisting the County Engineer in the review of subdivision plats, plans, specifications, and cost estimates for development and road projects. The Engineer will act independently to manage projects, bonds, and grants.

Essential Functions:

- 1. Project management for project initiation, design, and construction of various County related projects.
- 2. Program management for County Bonds and Grants.
- 3. Review plans for the construction of subdivisions, roads, and site development projects.
- 4. Review hydraulic and topographic surveys.
- 5. Review subdivision plats.
- 6. Review floodplain development permit packages.
- 7. Review and prepare preliminary cost estimates for construction projects.
- 8. Review and prepare engineering plans.
- 9. Research and determine right-of-way areas.
- 10. Review and prepare proposed construction designs for/with conformity with Federal, State, County regulations and specifications.
- 11. Respond to citizen inquiries and receive complaints on public work projects.
- 12. Prepare maps and charts for public presentations and meetings.
- 13. Train and communicate with other staff regarding permitting and plan review processes.
- 14. Performs related duties as required.

Minimum Qualifications:

- 1. Texas Professional Engineer License.
- 2. Minimum 5 Years of Engineering Experience.
- 3. Must have a valid Texas driver's license.

Knowledge, Skills and Abilities:

- 1. Ability to read and interpret engineering plans and specifications.
- 2. Ability to make mathematical calculations, with a strong understanding of geometry.
- 3. Ability to establish grades for streets, drainage areas and sewer construction projects.
- 4. Knowledge of computers and familiar with CAD software.
- 5. Skills in Geographic Information Systems (GIS) (preferred).
- 6. Knowledge of engineering practices.
- 7. Skills in managing project schedules, critical paths and resource management.
- 8. Ability to communicate with diverse groups of individuals utilizing tact and diplomacy.
- 9. Ability to establish and maintain effective working relationships with co-workers, County employees, other agencies and the general public.

Physical Requirements:

1. Physical requirements include frequent lifting/carrying of 10-25 lbs.; visual acuity, speech and hearing; hand and eye coordination and manual dexterity necessary to operate computer keyboard. Subject to balancing, handling, walking and reaching to perform the essential functions.

Working Conditions:

- 1. Working conditions are primarily inside; occasional exposure to traffic, excessive dust, rough terrain, wet surfaces, overhead power lines, high noise areas, unfavorable fumes, vapors and odors.
- 2. Subject to being on-call during emergency weather conditions; may be required to work more than 40 hours during the work week.
