Maintenance

Seven maintenance contracts are currently being advertised, with an expected five additional professional services contracts, and road bond contracts. Developing bid documents, negotiating contracts, advertising and procuring materials has placed a large demand on current staff without a dedicated purchasing staff. As a result, material procurement has been delayed, and the delivery of projects is at risk. Maintenance has been preparing roads for preventative seals with the remaining material available, until road material can be procured.


Accomplishments this period:

- Peregrine Estates drainage project.




Above: WCRB operators stabilize road subgrade in advance of a seal coat project on Cardiff Road.

- Created GIS database of substantially damaged structures for FEMA CAV.
- Awarded a contract to a Traffic Engineer Consultant for on-call tasks.
- Hired a Professional Engineer.
- Hired an Engineering Technician.

- Driveway and Culvert Regulations On Schedule (Summer 2024)
- myGov Permit Application Software Implementation Ahead of Schedule (2nd Qtr)
- Organization of electronic files

Geographic Information Systems (GIS)

Road inventory and mapping is complete. There are currently <u>524.24 miles</u> of road that Waller County is responsible to maintain. Approximately 50 miles are currently in construction or in the developer maintenance period.

Next steps:

- Basic GIS infrastructure is built, so we will transition to a maintenance and analysis role.
- A GIS technician could collect and update ongoing data (maintenance)
- Current GIS position could transition into data analysis

Other items the GIS staff is working on include:


- Developing a GIS inspection application to track deficiencies in field.
- Researching ESRI data collection applications to generate work orders remotely.
- Developing an open data portal for the public.

Financial

The Road and Bridge Department will remain under the approved budget this year. Delays in material procurement have impacted project delivery dates, which will affect the projects we can complete and the amount of material we can purchase. 
