Operations Report – Second Quarter FY 2024



Maintenance

Road & Bridge Maintenance has been busy during the Second Quarter. A few highlights are below:

- Closed Riley Road Bridge to one lane.
- Cleaned debris and ditch work following both April flood event and May Windstorm (DR 4781).
- Completed spot repairs on Waller Gladish, Old Houston, Howell, and Gassner Roads.
- Oversaw contractors picking up debris (DR 4781); Approximately 11,000 cubic yards collected.
- Placed asphalt level up on Emily Way and Beckendorff Road.
- Started rehabilitating Riley Road from Newland to Walnut Ridge.
- Began Peregrine Estates Drainage project.
- Celebrated the retirement of a long-time employee!



No bids were received on our seal coat projects. A few reasons for no responses may include:

- Limited advertising footprint (local newspapers vs. bid management database, ie~CIVCAST)
- Lack of dedicated staff
- Limited expertise on procurement and procurement law

Department resources need to be reassigned to perform maintenance seals in-house. ARPA seal coat projects will have to be readvertised with a revised scope and documents. As a result, delivery of some of this year's road rehabilitation projects will be moved to next year.





Engineering

We received fewer general plans for master planned developments in the second quarter, however, staff continues to receive and process a significant number of plats and plans. The number of engineering plan submittals and types for the second quarter can be viewed on the following charts:



Our plan intake has remained steady as a result of our submittal process. Submittal meetings have been booked up to a month in advance. By the end of the Summer, once myGOV has been implemented, we expect submittal numbers to increase with improved plan review tracking.



Our Assistant County Engineer, Luke Fortkamp, and his staff, are effectively managing the large plan submittal volume that we are experiencing. The graph below depicts the unprecedented growth in Waller County.



Managing this growth involves continued monitoring and reassessing needs and resources. As a result, we will be presenting periodic amendments to our Subdivision Rules and Regulations until the final and complete version can be adopted later this year.

Geographic Information Systems (GIS)

The GIS Division will be transitioning into a maintenance role, with plans to restructure staff to monitor real time information during emergency operations.

GIS work continues to include:

- Developing a GIS inspection application to track deficiencies in field.
- Researching ESRI data collection applications to generate work orders remotely.
- Developing an open data portal for the public.

Waller County Road Bond

The Program Manager, LJA Engineering, has met with each commissioner to better understand project priorities and goals. Construction cost estimates and project scopes are being refined with greater detail. The following items are expected to be accomplished next quarter:


- Road cores to investigate pavement structure.


