## NOTICE OF RECEIPT OF APPLICATION AND INTENT TO OBTAIN WATER QUALITY PERMIT RENEWAL

PERMIT NO. WQ0015443001

**APPLICATION.** Fulshear Municipal Utility District No. 3B, 9 Greenway Plaza, Suite 1000, Houston, Texas 77046, has applied to the Texas Commission on Environmental Quality (TCEQ) to renew Texas Pollutant Discharge Elimination System (TPDES) Permit No. WQ0015443001 (EPA I.D. No. TX0136883) to authorize the discharge of treated wastewater at a volume not to exceed a daily average flow of 960,000 gallons per day. The domestic wastewater treatment facility is located approximately 1.46 miles southeast of the intersection of Interstate Highway 10 and Woods Road, in Waller County, Texas 77423. The discharge route is from the plant site to a drainage ditch; thence to Willow Fork Buffalo Bayou; thence to Buffalo Bayou; thence to Buffalo Bayou Above Tidal. TCEQ received this application on December 17, 2019. The permit application is available for viewing and copying at Waller County Brookshire-Pattison Library, 3815 6<sup>th</sup> Street, Brookshire, Texas. **ADDITIONAL NOTICE.** TCEQ's Executive Director has determined the application is administratively complete and will conduct a technical review of the application. After technical review of the application is complete, the Executive Director may prepare a draft permit and will issue a preliminary decision on the application. **Notice of the Application and Preliminary Decision will be published and mailed to those who are on the county-wide mailing list and to those who are on the mailing list for this application. That notice will contain the deadline for submitting public comments.**

**PUBLIC COMMENT / PUBLIC MEETING.** You may submit public comments or request a public meeting on this application. The purpose of a public meeting is to provide the opportunity to submit comments or to ask questions about the application. TCEQ will hold a public meeting if the Executive Director determines that there is a significant degree of public interest in the application or if requested by a local legislator. A public meeting is not a contested case hearing.

**OPPORTUNITY FOR A CONTESTED CASE HEARING.** After the deadline for submitting public comments, the Executive Director will consider all timely comments and prepare a response to all relevant and material, or significant public comments. **Unless the application is directly referred for a contested case hearing, the response to comments, and the Executive Director's decision on the application, will be mailed to everyone who submitted public comments and to those persons who are on the mailing list**
