## **Waller County Fire Code Fee Schedule**

Fees are due before any service or review conducted by the Waller County Fire Marshal. All fees paid to the Waller County Fire Marshal's Office are non-refundable. A submittal is not considered complete until all required documentation, including payment, is received. The fee includes the administrative paperwork, plan review, and inspection required to complete the Certificate of Compliance. The Commissioners Court must approve any variances to the fee schedule.

Re-Inspections. A re-inspection fee must be paid before any re-inspection is rescheduled. The fee also covers failure to attend a scheduled fire inspection without prior notice, or a planned fire inspection that is not canceled at least four hours before the scheduled time and date.

Re-Inspection Fee is \$150.
