

Houston to Hearne Pipeline Project



Project overview

- The Houston to Hearne pipeline is a proposed pipeline system that would transport refined petroleum products from Houston to Hearne, Texas. It will be built and operated by Magellan Midstream Partners, a leader in the nation's energy transportation and storage industry
- The project consists of approximately 135 miles of 16- or 20-inch diameter pipeline with an initial design capacity of 150,000 barrels per day
- The specific route of the pipeline is still being determined but Magellan expects to use existing right-of-way for a significant portion of the route



Why is this project needed?

Magellan's pipeline system is capacity-constrained and increased demand for U.S. Gulf Coast refined products supply in Dallas, the Mid-Continent region and west Texas has magnified the need for additional pipeline infrastructure

Advantages

- . The pipeline is expected to create direct and indirect jobs along the route, primarily during the construction phase
- It would generate ad valorem taxes in the counties in which the pipeline is located (Robertson, Brazos, Grimes, Waller and Harris)
- Pipelines are the safest, most reliable and most cost effective mode of transporting a large volume of liquid energy from where it is produced to where it is consumed
- Dependable pipelines help the country to be energy secure by transporting refined products from where they are produced to the end user

Houston to Hearne Pipeline Project

Project timeline

 Construction is expected to begin during second quarter 2018 with plans to put the pipeline into service during the first half of 2019

Regulatory information

- The pipeline would be designed, built and operated to strict safety standards and would be regulated by the Texas Railroad Commission, the Federal Energy Regulatory Commission (FERC) and local government entities
- The pipeline would be monitored around the clock, 365 days a year from Magellan's state-of-the-art control room facilities
