Other Items the R&B Maintenance Department is working on include:


- Uniform Rental Agreements Approved 11/15/23

### **Engineering**

We have updated our submittal process and moved to an in-person submittal. This will allow us to better track plan reviews, and meet required deadlines. Once staff are trained, and our work process is refined, we will consider electronic submittals.



We are refining our plan submittal flow chart. Flow charts and guidance documents will be added to the Road and Bridge webpage upon completion.

#### FEMA – Community Assistance Visit (CAV) 2023

In February 2023, FEMA initiated an audit of our floodplain management records. The audit, known as a CAV, is a routine check that FEMA performs to ensure that the local government is in compliance with our ordinance. A few key points are below:

- Waller County needs to track substantially damaged properties. Substantially damaged is defined as damaged more than 50% of a structure's value.
  - o Waller County will begin tracking damaged structures via GIS.
  - o Waller County will need to adopt a Substantial Damage Response Plan. A draft is in process and will be presented to Commissioner's Court at a future meeting.
- FEMA's CAV concludes on December 15, 2023.
- Waller County's Floodplain Ordinance exceeded FEMA's minimum requirements to be a member in the National Flood Insurance Program.


Other Items the Engineering Department is working on include:

## Geographic Information Systems (GIS)

The GIS team has been busy inventorying county road mileage, pavement conditions, culvert sizes, culvert conditions, road signs, striping, and guardrail. To date staff has logged 384 miles of road, 2,000 signs, 1,500 culverts, over 100 miles of striping and 10,000 feet of guardrail. This next quarter, the GIS team will finish the final phase of data collection and clean up data sets.
