### TEMPORARY STANDING ORDER REGARDING CORONAVIRUS DISEASE (COVID-19) MITIGATION AND ALL JUSTICES OF THE PEACE IN WALLER COUNTY (ORDER NO. 2)

Due to coronavirus disease (COVID-19), the four Justices of the Peace of Waller County issue the following order based on the First Emergency Order Regarding the COVID-19 State of Disaster from the Supreme Court of Texas (Misc. Docket No. 20-9042) and the Court of Criminal Appeals of Texas (Misc. Docket No. 20-007). This order is issued to protect the community, limit exposure, and provide for an efficient judicial system:

Subject only to constitutional limitations, all scheduled court proceedings are hereby suspended until April 12, 2020. Each Justice Court will contact the litigants to notify them of the new reset date as soon as practical for the court.

The statute of limitations in any civil case, in which the statute of limitations matures within 30 days of the date of this order, shall be extended for a period ending no later than 30 days after the Governor's state of disaster has been lifted.

No debt claim or small claim setting will be held until after April 10, 2020. No writs on small claims or debt claims, will be issued by a Justice Court for 60 days after the date of this order, unless deemed appropriate by the presiding Judge.

By order of the Supreme Court of Texas (Misc. Docket No. 20-9045) no trial, hearing, or other proceeding on an eviction case will occur until after April 19, 2020, unless allowed by that order. Additionally, a Writ of Possession may issue, but posting and execution of said writ may not occur until after April 26, 2020.


For Traffic and Criminal Class C citations and summons, including parent contributing to non-attendance and truancy, with an appearance date prior to April 10, 2020, the appearance date will be extended and the court with jurisdiction will notify defendants of a new appearance date. No warrants due to failing to appear for Traffic or Criminal Class C citations, or summons, will be issued for 60 days from the date of this order.

In compliance with the Order from the Supreme Court of Texas (Misc. Docket No. 20-9044) and the Court of Criminal Appeals of Texas (Misc. Docket No. 20-008), any hearing by a

court after a date set in this order will comply with the most restrictive of any local, state, or national directive regarding maximum group size, until May 8, 2020.

This order amends and replaces the "Temporary Standing Order Regarding Coronavirus Disease (COVID-19) Mitigation and All Justices of the Peace in Waller County (Order No. 1) issued on March 17, 2020.
