## *Notice to Neighboring Systems, Customers, and Cities* NOTICE OF APPLICATION OF QUADVEST, LP TO AMEND ITS CERTIFICATES OF CONVENIENCE AND NECESSITY TO PROVIDE WATER AND SEWER UTILITY SERVICE IN WALLER COUNTY, TEXAS

Quadvest, LP has filed an application with the Public Utility Commission of Texas to amend its water Certificate of Convenience and Necessity (CCN) No. 11612 and sewer CCN No. 20952 for the provision of retail water and sewer utility service in Waller County, Texas.

<u>The requested area overlaps the district boundaries of Brookshire Katy Drainage District and</u> <u>Waller County Municipal Utility District 58.</u> If these districts do not request a public hearing, the Commission shall determine that the district is consenting to the Quadvest, LP's request to provide retail water and sewer utility service in the requested area.

The requested area is located approximately <u>2.4</u> miles <u>northwest</u> of downtown <u>Katy</u>, Texas, and is generally bounded on the north by <u>Clay Road</u>; on the east by <u>Pitts Road</u>; on the south by <u>Morton</u> <u>Road</u>; and on the west by <u>Schliph Road</u>.

The requested area includes  $\underline{0}$  customer connections and approximately  $\underline{220.9}$  acres of uncertificated area to amend (add) to CCN Nos. 11612 and 20952. The application proposes the addition of approximately  $\underline{220.9}$  acres to CCN Nos. 11612 and 20952.

Persons who wish to intervene in the proceeding or comment upon action sought should contact the Public Utility Commission, P.O. Box 13326, Austin, Texas 78711-3326, or call the Public Utility Commission at (512) 936-7120 or (888) 782-8477. Hearing- and speech-impaired individuals may contact the commission through Relay Texas at 1-800-735-2989\*. The deadline for intervention in the proceeding is (30 days from the mailing or publication of notice, whichever occurs later, unless otherwise provided by the presiding officer). You must send a letter requesting intervention to the commission which is received by that date.

The letter must include the person's name, address, email address, and fax number, if applicable.

\**Hearing- and speech-impaired individuals with text telephones (TTY) may contact the commission directly at (512) 936-7136.* 

If a valid public hearing is requested, the Commission will forward the application to the State Office of Administrative Hearings (SOAH) for a hearing. If no settlement is reached and an evidentiary hearing is held, SOAH will submit a recommendation to the Commission for final decision. An evidentiary hearing is a legal proceeding similar to a civil trial in state district court.

A landowner with a tract of land at least 25 acres or more, that is partially or wholly located within the requested area, may file a written request with the Commission to be excluded from the requested area ("opt out") within (30) days from the date that notice was provided by the Utility. OBVIDDED

All opt out requests must include a large-scale map, a metes and bounds description of the landowner's tract of land, landowner's name, address, email address and fax number, if applicable.

A landowner that opts out from the requested area releases the applicant's obligation to provide retail water or sewer utility service to the removed land for any reason.
