## NOTICE OF RECEIPT OF APPLICATION AND INTENT TO OBTAIN WATER QUALITY PERMIT AMENDMENT

**PERMIT NO. WQ0002699000**

**APPLICATION.** Luminant Mining Company LLC, 6555 Sierra Drive, Irving, Texas 75039, which owns a surface lignite coal mining facility, has applied to the Texas Commission on Environmental Quality (TCEQ) to amend Texas Pollutant Discharge Elimination System (TPDES) Permit No. WQ0002699000 (EPA I.D. No. TX0076465) to authorize renaming the following ponds and outfalls: Pond Q-10 (Outfall 020M/R) will be revised to Pond Q-17 (Outfall 028M/R); Pond Q-9 (Outfall 021M/R) will be revised to Pond Q-11 (Outfall 022M/R); and Pond Q-8 (Outfall 019M/R) will be revised to Pond Q-10 (Outfall 021M/R) and the addition of the following ponds and outfalls: Pond Q-11 (Outfall 022M/R); Pond Q-12 (Outfall 023M/R); Pond Q-13 (Outfall 024M/R); Pond Q-14 (Outfall 025M/R); Pond Q-15 (Outfall 026M/R); Pond Q-16 (Outfall 027M/R); Pond Q-17 (Outfall 028M/R); Pond Q-18 (Outfall 029M/R); and Pond D-14 (Outfall 030M/R). The facility is located at 4731 State Highway 7 East, east of the cities of Kosse and Bremond, in Limestone and Robertson Counties, Texas 76653 and 76629. The discharge route is via Outfalls 001 M/R, 003M/R, and 030M/R to unnamed tributaries; via Outfall 002M/R to Heads Creek; via Outfall 007M/R to Steele Creek; via Outfall 005M/R to Willow Creek; via Outfall 006M/R to Cox Creek; via Outfall 008M/R to Owens Creek; via Outfall 010M/R to an unnamed tributary, thence to Willow Creek; thence all outfalls to Steele Creek, thence to Navasota River Below Lake Limestone. The discharge route is via Outfall 011M to an unnamed tributary; via Outfalls 012M/R, 013M/R, and 015M/R to Walnut Creek; via Outfalls 014M/R, 016M/R and 023M/R to an unnamed tributary, thence to Gnats Creek; via Outfalls 017M/R, 018M/R, and 019M/R to Gnats Creek; via Outfalls 020M/R, 021M/R, 022M/R, 024M/R, 025M/R, 026M/R, 027M/R, and 029M/R to an unnamed tributary of Beck Creek, thence to Beck Creek; via Outfall 028M/R to Beck Creek, thence all to Walnut Creek, thence to Little Brazos River, thence to Brazos River Above Navasota River. TCEQ received this application on January 30, 2026. The permit application will be available for viewing and copying at Limestone County Clerk's Office, 200 West State Street, Suite 102, Groesbeck, in Limestone County, Texas, and at Robertson County Clerk's Office, 103 East Morgan Street, Franklin, in Robertson County, Texas prior to the date this notice is published in the newspaper. **ADDITIONAL NOTICE.** TCEQ's Executive Director has determined the application is administratively complete and will conduct a technical review of the application. After technical review of the application is complete, the Executive Director may prepare a draft permit and will issue a preliminary decision on the application. **Notice of the Application and Preliminary Decision will be published and mailed to those who are on the county-wide mailing list and to those who are on the mailing list for this application. That notice will contain the deadline for submitting public comments.**

**PUBLIC COMMENT / PUBLIC MEETING.** You may submit public comments or request a public meeting on this application. The purpose of a public meeting is to provide the opportunity to submit comments or to ask questions about the application. TCEQ will hold a public meeting if the Executive Director determines that there is a significant degree of public interest in the application or if requested by a local legislator. A public meeting is not a contested case hearing.

**OPPORTUNITY FOR A CONTESTED CASE HEARING.** After the deadline for submitting public comments, the Executive Director will consider all timely comments and prepare a response to all relevant and material, or significant public comments. **Unless the application is directly referred for a contested case hearing, the response to comments, and the Executive Director's decision on the application, will be mailed to everyone who submitted public comments and to those persons who are on the mailing list for this application. If comments are received, the mailing will also provide instructions for requesting reconsideration of the Executive Director's decision and for requesting a contested case hearing.** A contested case hearing is a legal proceeding similar to a civil trial in state district court.

**TO REQUEST A CONTESTED CASE HEARING, YOU MUST INCLUDE THE FOLLOWING ITEMS IN YOUR REQUEST:** your name, address, phone number; applicant's name and proposed permit number; the location and distance of your property/activities relative to the proposed facility; a specific description of how you would be adversely affected by the facility in a way not common to the general public; a list of all disputed issues of fact that you submit during the comment period and, the statement "[I/we] request a contested case hearing." If the request for contested case hearing is filed on behalf of a group or association, the request must designate the group's representative for receiving future correspondence; identify by name and physical address an individual member of the group who would be adversely affected by the proposed facility or activity; provide the information discussed above regarding the affected member's location and distance from the facility or activity; explain how and why the member would be affected; and explain how the interests the group seeks to protect are relevant to the group's purpose.

Following the close of all applicable comment and request periods, the Executive Director will forward the application and any requests for reconsideration or for a contested case hearing to the TCEQ Commissioners for their consideration at a scheduled Commission meeting.

The Commission may only grant a request for a contested case hearing on issues the requestor submitted in their timely comments that were not subsequently withdrawn. **If a hearing is granted, the subject of a hearing will be limited to disputed issues of fact or mixed questions of fact and law relating to relevant and material water quality concerns submitted during the comment period.**

**MAILING LIST.** If you submit public comments, a request for a contested case hearing or a reconsideration of the Executive Director's decision, you will be added to the mailing list for this specific application to receive future public notices mailed by the Office of the Chief Clerk. In addition, you may request to be placed on: (1) the permanent mailing list for a specific applicant name and permit number; and/or (2) the mailing list for a specific county. If you wish to be placed on the permanent and/or the county mailing list, clearly specify which list(s) and send your request to TCEQ Office of the Chief Clerk at the address below.
